### 1. About the College

Devi Sharvani Education Society was founded by Late Mr. V. M. Salgaocar, an industrialist and philanthropist of Goa in the year 1972 and is registered under the Societies Registration Act, 1860. Mahadevrao Salgaocar College of Law was established in the year 1973 with a generous donation from the founder, Late Mr. V. M. Salgaocar, who named the college in the memory of his father Late Mr. Mahadevrao Salgaocar. The College was started with the view to meet the long-felt need of the people of Goa for Legal Education. In the year 1997, as per the decision of the Governing Council, the name of the College was changed to V.M. Salgaocar College of Law (VMSCL).

The College is situated on a spacious plot of land at Miramar with an edifice of 2525.72 m2 with an adjoining Library building of 2379.93 m2 . There are a sufficient number of classrooms which are spacious, well-ventilated and well-lit, and which are also air-conditioned. Provision has been made of LCD projectors & internet connections in each and every classroom. The College also has three air-conditioned Staff Rooms, a well-resourced Moot Court Room, a big air-conditioned Conference Hall, a Governing Council Room, a Child Rights Clinic Room, a spacious Canteen, a well-equipped Gymnasium, a separate Book Bank and other facilities. The college has an independent three-storied library named the 'HIRABAI V. SALGAOCAR LIBRARY' which is 3 well-equipped including online legal databases and a digital library. It is the third largest library in Asia. The library hosts a unique collection of rare reports. The College Library is fully automated and computerized with open access system. Besides a vast collection of law books, there are also books that cater to diverse interests. Online e-journals, AIR manuals and CDs with multiple user facilities are made available. Over five lakh pages of rare journals are digitized.

Further, the college premises are kept under constant CCTV surveillance. The College is a full[1]time College and functions from 8.00 a.m. to 5.00 p.m. It has well-qualified and competent teaching faculty and administrative staff.

The Mission of the College is 'Excellentia Justitia et Humanitas' which means "Excellence in Legal Education, in Pursuit of Justice and Service to Humanity". The College is committed to academic excellence and affords opportunities for knowledge acquisition and adaptation through training, research, consultancy service to the public, and through outreach activities. V. M. Salgaocar College of Law is the first Law College in India, to secure 'A' grade rating from NAAC in 2005, and yet again in its re-accreditation in 2012. In 2011, the College was conferred the 'INSTITUTIONAL EXCELLENCE AWARD' for its outstanding efforts in imparting legal

education and for its commitment in reaching out to the public through its Permanent Legal Aid Cells.

The Vision of the College is "Let Justice be Done Though the Heaven Fall." The College inspires, motivates and challenges the teacher and the pupil alike, to the attainment of excellence in the field of legal education and emphasizes respect for human dignity and the inculcation of basic values crucial to the legal profession. The College encourages uninhibited democratic ideas and endeavours to translate those ideas for the benefit of the Nation. As a result, the curriculum is carefully chosen, the faculties are dedicated to the cause of promoting access to justice, and students are geared towards community interaction. This is the legacy of legal education for the benefit the community that has defined VMSCL's reputation and which gives it a cutting edge over the other institutions.

### **II. Law Programmes**

### A. Bachelor of Law Programmes (B.A. LL.B. & LL.B. Degree)

The Bachelor of Law Degree Programme at this College is a Professional Degree Programme and is especially designed for those who intend to take Law as a profession, either as advocates, or law consultants, or law officers, or any other related legal field.

### VMSCL offers two Bachelor Degree programmes namely,

- (i) B.A.LL.B. Five-Year Integrated Law Programme (Five-year programme) and
- (ii) LL.B. Degree (Three-Year Programme).

The B.A.LL. B Five Year Integrated Law Programme is a highly professional full-time programme leading to dual degrees, a Degree in Arts and a Bachelor's Degree in Law. The Five-Year Integrated Law programme introduced by the Bar Council of India, adheres to the standards prescribed by the UGC and is approved by the Goa University.

The College also offers a three-year Professional Law Degree Programme (LL.B. Degree) recognized by the Bar Council of India. This is for students who have already completed their graduation in some other discipline and now wish to pursue Law as a career. The study of law during these three year stretches much beyond books and engages the students in development of their talents as well as in community participation. Social contexting of the students' practical

training programme is visible in the proactive social action by the student body filing substantial number of Public Interest Litigations (PIL) on various issues, in the High Court of Bombay at Goa.

The college focuses on learner centred teaching and in addition to the lecture method, it incorporates into the teaching process, various activities like seminars, debates, group discussions to further meaningful participation of students. Clinical Legal Education is effective imparted through Moot Court, Client Interview & Counselling, Mock Trial, Negotiation, Mediation, Legal Aid, Law Clinics, Law Clubs and other related projects.

Students are required to participate in Moot Courts organized by the College, attend the Legal Aid Cells every weekend, attend Court, learn Court ethics, follow up cases, and attend a lawyer's office, as required under the teaching program. All students are provided a platform to participate in a plethora of competitions such as debates, skits, moot courts, client counselling, mediation, negotiation etc. Such competitions are based on legal topics and mock cases which are organized at the state level, national, and international level. This gives them an opportunity to undergo pre-training exposure simultaneously while pursuing their studies.

The Law Degree Programme is an intensive course and the students are required to be actively involved in the activities of the College. They have to also undergo internship training during their 4th and 5th year of the course. The College has also established a permanent Consumer Clinic, Prisons' Clinic, Child Rights Clinic and Centre for Disability Rights to provide legal aid to the aggrieved parties. The College is also known for rendering valuable, tangible and free-of-cost service to the community in the State of Goa through its Legal Aid activities. The Institution is unique for having 26 permanent Legal Aid Cells established in Goa for creating legal awareness on laws, obtaining senior citizen cards and Krishi Cards, to check implementation of welfare schemes and to provide such other legal-related services.

A robust sports culture is encouraged at VMSCL, and students have a choice of joining different sports activities. The NSS unit of the college is also very active and offers lots of productive activities to the students.

### B. Masters of Law and Doctoral Programmes (LL.M. and Ph.D.)

With a view to offer a Post-graduate program to the B.A.LLB or Law Graduate Students of Goa, VMSCL introduced an LL.M. Program by establishing a PG Department in Law in the year 1998. The College offers a two-year LL.M. Masters' Programme comprising four semesters. A law graduate from any Indian or foreign university recognized by the UGC and Bar Council of India, with at least 50% marks or equivalent grade [45% for SC/ST Candidates], can apply for admission to this programme. The objective of the LL.M. Programme is to develop legal

academic acumen among the law graduates through an expert teaching programme, interdisciplinary inquiry and through practical appreciation of legal problems. The LL.M. program has been conducted successfully over a decade and half and has produced high quality students who have excelled in various fields not only in Goa but other parts of the country. From the academic year 2016, the College has heralded a new era in legal education in Goa by adopting the LL.M. Program of the Goa University with a Choice Based Credit System of Instruction. This is to enable those students who have passed the LL.B. professional programme to seek academic excellence and to facilitate job opportunities, which require higher level of legal learning.

VMSCL is also recognized as a Research Centre for Ph.D. Degree and has several qualified faculty members who have successfully guided several PhD candidates.

### C. Certificate Programmes

Certificate Courses are conducted to provide participants a varied exposure to different aspects of law in the globalizing world. This year, the college organized two such courses, despite the covid challenge.

### 1. Certificate Course in Communication Skills – 'Write Better, Speak Better'

Course coordinators: Ms. Jyoti Kiran Pisipati, Assistant Professor in English and Ms. Shruti Kamat Dalal, Assistant Professor in Law.

'Write Better, Speak Better' was a one-week certificate course designed to teach basic spoken and written English skills for the Multi-tasking Staff (MTS) of the college to improve their professional and personal communication. The course was conducted from 3rd – 9th July 2021. At the end of the course, learners were evaluated on spoken and written English and awarded certificates.





### The course objectives:

- a) To teach basic grammar used in spoken and written English
- b) To teach techniques that help improve vocabulary
- c) To boost their confidence in professional and personal communication spaces and facilitate an easy flow of speech
- d) To encourage creativity through the use of language
- e) Teach formal letter-writing skills

The resource persons for the week-long course were Ms. Jyoti Kiran Pisipati, Assistant Professor in English and Ms. Trisha Almeida, Counsellor, V M Salgaocar College of Law.

# 2. Certificate Course in Entrepreneurship Development Organized By Economics and Innovations Forum of V.M.Salgaocar College of Law

Course Coordinator: Danica Menezes, Assistant Professor

Entrepreneurship Development is an emerging field of opportunities. This course is a way of enhancing the skills and knowledge of individuals with help of training them with the required assistance.

The objective of floating this certificate course for the students of law in particular is to help them get an understanding of entrepreneurial skills and the process of startups which is now going to be the probable future of students. The certificate course targets the basic topics of entrepreneurship development and also aims at giving students practical understanding of how a business idea can be put into practice. The certificate course received a good response as there were a total of 76 students who registered for the same. During the course, the students also got an opportunity to interact with entrepreneurs who have established themselves in business. They were made aware of the practical difficulties that arise during the process of setting up a business and how one should deal with these difficulties. The Certificate Course concluded with a Course End Examination in which students had to present their Business Plan, projecting their business ideas.



### (vi) Committee under Right to Information Act, 2005

Right to access information held by public bodies is a fundamental right guaranteed under the Constitution of India. The Supreme Court of India accepted this right as an inherent part of Right to Freedom of Speech and Expression and the Right to Life and Personal Liberty. The court judgments are not sufficient to provide transparency, openness and accountability at the grass root level. There was a need to enact a separate legislation to guarantee the Right to Information to each and every citizen.

In this direction the Union government made the Right to Information Act, 2005. The main purpose of the Act is to bring transparency, openness and accountability in administrative process in each and every department. This Act came into force on 12<sup>th</sup> October 2005.

Under the RTI Act *Sec.5 (1)* imposes a duty on the Public Authority to designate State Public Information Officers in all administrative units or offices as may be necessary to provide information to persons requesting for the information under this Act.

## IX. Reports of Activities

## 1. ADR Board

The ADR Board was initiated with the aim of inculcating among law students the amicable settlement approach rather than the adversarial approach towards the client's issues. The students are expected to learn the purpose, skill and techniques of the alternative dispute resolution methods like Negotiation, Mediation, Conciliation, etc. The membership of the board is the outcome of a rigorous screening procedure from amongst the numerous interested students.

The Members once selected, are trained in the ADR techniques through orientation and experience sharing sessions. These members represent the college in various National as well as International ADR competitions. The Board also conducts client counseling orientations and training for the competitions. This year the members of the Board have made us proud by winning the most prestigious Competitions, national as well as international. The Board is also instrumental in hosting 'Lex Infinitum', the International Dispute Resolution Competition every year.

#### a. The MOU

## (i) VMSCL-AIDR Partnership

We have entered into an MOU with the AIDR (Association for International Dispute Resolution) headed by Thomas Valenti, (attorney from USA), Mr.Tanmay Pandey and Mr.Harshit Pandey. This MOU is mainly for the purpose of conducting Lex Infinitum and also other sessions for ADR. The MOU is operative for a period of 2 years (2020-21 & 2021-22).

## (ii) VMSCL- Mediator Academy Partnership

We entered into an MOU with the Mediator Academy, London, UK in July 2021. The purpose is to provide online educational opportunities to our students as well as other students registered with us to do a Mediation Certificate Course.

#### b. Selection to ADR Board

The members of the Board are selected each year through a rigorous screening procedure which requires them to participate in a negotiation session with other participants. This year due to the difficulty which the pandemic has posed, the Board had to rethink and innovate the process of selection. There were consultations held with the Advisory Committee as well as existing Board members regarding the process of ADR selection keeping in mind the need to adapt to the recent times. It was thereby decided to have the selection process online.

## (i) Notice and Registration

Notice was issued on 22-09-2020 announcing the selection rounds dates and seeking registration from the interested students by posting google form for the purpose of seeking information including their name, class, contact details, email ids, whether selected to Board in previous year, etc. Registration was kept open till 30.09.2020. The selection rounds were open for all the classes except the F.Y.B.A. LL.B. Total of 92 students registered for the selection rounds.

## (ii) Problem for Selection

The problem for the Selection round was communicated to the participants through their email ids as well as in class watsapp group. The title of the problem was "Size Does Matter" and it was a negotiation between Amit Bhusulu and Shyam Tari. The Problem was framed by Prof. Dr. M.R.K.Prasad and Dr. B.S. Patil.

#### (iii) Exemption

Keeping into consideration the changed circumstances, the Board adopted a different policy of exemption this year. All those students who were members of the Board in the previous year and were interested in continuing with membership, were exempted from selection rounds for this year.

## (iv) Training/Orientation

Training for the students who registered for selection rounds was conducted on 10-10-2020 by Prof. M.R.K. Prasad and Dr.B.S.Patil. This was done through googlemeet. The students were trained about the process of negotiation, its types and the format of the selection. They were also informed about the judging criterion which was based on identification of interest, Relationship building and problem solving, Building Confidence, Mutually generating creative options and legitimizing it, Professionalism and Effective Negotiation Skills. A watsapp group of participants was also formed for further communication.

## (v) Assessors for the Selection round.

There were 7 assessors for the selection round; 4 practicing advocates (Adv.Sydney Cardozo, Adv. Bernard D'souza, Adv.Jayant Karn, Adv.Elton Furtado) and 3 faculty members (Prof. M.R.K.Prasad, Ms. Pearl Monteiro and Mr.Aamod Shirali). Orientation was held through google meet on 29<sup>th</sup> Oct to brief the judges about the schedule and discuss the judging criterion. All the relevant details including problem, judging criterion, schedule, etc was communicated to the judges through a watsapp group created for Assessors.

## (vi) Selection Round

Selection rounds of the ADR Board were a trial round for Lex Infinitum which would be held in Feb 2021. Therefore, the Organising Committee members were put in charge of conducting the online process of selection. Selection round was held on 30.10. 2020 in which 42 students participated. There were a total of seven Judges assessing students in two to three sessions each. There were 2 CI rooms created and 7 google meet links for selection rounds. 4 back up students were used to fill in vacant slots due to loss of connectivity, etc.

A total of 18 students were selected and results were displayed on the college website and sent to the class whatsapp group on 02.11.2020. ADR Board comprised of a total of 65 students including newly selected students.

## f. ADR Practical Paper

Training for Negotiation was given to the B.A.LL.B final year students by Dr. B.S.Patil during the regular ADR lectures. Training was conducted for T.Y. LL.B Degree by Prof. Dr. M.R.K Prasad and Dr. B.S.Patil in the month of June. This year due to Pandemic, it was not feasible to conduct actual negotiation sessions in college. 
**Knowledge Session Day 1 (18.02.2021)** 

## 1. Catherine Davidson

The Knowledge Sessions for the year 2021 kicked off with a session by Catherine Davidson, a trained and certified from Australia. She began her session for the day by showing everyone the diamond model of mediation. She further went on to state the importance of a mediator's opening statement and how it should provide structure to the session and let the parties know that they are in safe hands, talk about time constraints of any and she also talked about the importance of note taking during the session.

#### 2. Charles LaFond

The second session on Day 1 was by Charles LaFond, an Austrian trained and certified mediator. He focused on the basic structure of mediation. He talked about one off deals in mediation. He also gave real life examples and integrated them into his session. He moved onto the styles of mediation and how to establish stability in an unstable environment. He taught us how to prepare for a negotiation process, how to set your agenda and how to clarify your agenda. He emphasised how information is important and how one must start to explore and share information to build trust and a rapport.



**Knowledge Session Day 2 (19.02.2021)** 

#### 1. Josephine Reyes

Day 2 of the knowledge sessions began with an informative session by Josephine Reyes. She talked about effective communication and online communication skills given that nowadays mostly everything is now online. Josephine started her session with a successful Q/A session after which she started talking about the advantages of online mediation like how it saves a lot of money or how it's useful in cases where there's a large power imbalance or in hostile cases. Mediation from home is useful as the parties are in familiar surroundings which are soothing. She explained the concept of shuttle mediation and told us how online mediation isn't a new thing and has actually been practiced for a long time along with over a call or telephone mediation. She mentioned how empathy and rapport building is difficult online as it's difficult to read a person via a screen. She concluded her session with the topic of active listening. She ended her session with another Q/A session.

## 2. Gregory Bond

The second session on the second day was taken up by Gregory Bond from the United Kingdom. He spoke about information gathering and how it is an interesting concept. He talked about how

information gathering must be done in a mediation session. He went on to discuss the difference between mediation and litigation and how it's voluntary and how it's not conducted under an oath and doesn't consist of any kind of cross examination. He went on to speak about what kind of information you gather from your clients and what is going throughout the information gathering process like determining the strength of their case, weaknesses of their case and whether they can afford it. He mentioned the importance of showing genuine interest in your client and asking genuine questions and that respecting the client's autonomy is a must. "Gathering information is an art, " Gregory said. He concluded his session with a Q/A session.

## **Knowledge Session Day 3 (20.02.2021)**

#### 1. Thomas Valenti

The final day of the Knowledge Sessions kicked off with a session by the one and only Thomas Valenti, who spoke on what's working what's not in a mediation session. "Don't blame others and see what's not working", said Thomas. He discussed the critical elements of a mediation session like gathering information, talking about time constraints and deadlines, and how to build positive communication skills by examining, concentrating, asking and summarising.

#### 2. Damali Peterman

The final Knowledge Session for the year 2021 was conducted by Damali Peterman whose topic was precautions of settlement agreements. Damali conducted a very informative session in which she explained how one can draft a settlement agreement and what are the Do's and Don'ts while doing so. "Settlement agreements should be appealing, accurate, do-able and precise" said Damali, who conducted a very interactive session and ended her session with a very interesting Q/A session.



## 2. Lex Infinitum 2021

Lex Infinitum, International Dispute Resolution Competition has been conceived for the purpose of promoting the use of ADR and to provide law students and ADR experts from all over the globe with a platform to network, innovate and keep abreast of the latest happenings in the field of ADR in India as well as abroad.

OUR GOAL: To provide law students with an opportunity to showcase their ADR skills and techniques and test their mettle against the creme de la creme of the law student fraternity from different parts of the world.

#### Our collaboration

Lex infinitum is one of the most prestigious events on par with prominent international ADR competitions like ICC Paris and CDRC Vienna. Due to the successful hosting and the credibility that the competition has been able to achieve at the international level, we have entered into an MOU with the AIDR (Association for International Dispute Resolution) headed by Thomas Valenti, (attorney from USA), Mr. Tanmay Pandey and Mr. Harshit Pandey. #### The event schedule and format

## **b.** Mediation Musings (19.02.2021)

Day 2 (19<sup>th</sup> Feb 2020) also consisted of Mediation Musings, an initiative by V.M. Salgaocar College of Law which aims to spread awareness about alternative dispute resolution. Mediation Musings was a panel discussion and was open to the general public. It had seventy-eight attendees.



The topic of this year's session was "Hammer Out A Deal Not Ethics – Ethical Dilemmas In Mediation" and the panel consisted of 4 highly regarded speakers in the field of ADR - Thomas Valenti who spoke about the dilemma of confidentiality, its benefits and its downsides too, next up was Dr. B.S. Patil who spoke on whether ethics in a legal practice are enough for mediation and whether or not a separate legislation is required for mediation. Next up to speak was Allison Malkin who spoke on the recipe for success in a mediation session. She also emphasized how mediational mediators are not there for opinions but are there a merely as a neutral party. Finally, we had Catherine Davidson whose topic was self-determination and determining by self or by situation. In all it was a wonderful and informative session by all the panelists.

Competition was conducted over a period of five days. It consisted of five different problems for each round. There were 9 rooms created for initial 3 days which were managed by 18 volunteers.





Legal Aid is a unique activity, which is in consonance with the College motto of 'Excellence in Legal Education in pursuit of Justice and Service to Humanity'. Helping the community concept has been going on in this College since 1998. This mammoth activity comprising 26 permanent free legal aid cells spread across the State of Goa. The concept of legal aid facility includes legal literacy, para legal services and pre-litigation process to the disadvantaged community. It extends also to representations, public interest litigation, law reforms, enforcement and implementation of law in practice. Our legal aid services are unique in nature and recognized by many well-known institutes in India as well as in foreign countries. The Planning Commission of India recognized the efforts of the college and students in its report.

All students are members of Legal Aid Cells for a period of minimum two years. Every year each member has to conduct 4 minor programmes to create awareness and one major programme/project for each legal aid cell.



# 6. Child Rights Clinic

The Child Rights Clinic has been established with the primary objective of building of a 'child-friendly' society in the State. The motto of the Clinic is - "WHERE CHILDREN ARE INSPIRED TO DEFEND THEIR RIGHTS." The Clinic works in close association with the Department of Women and Child Development, Goa State Commission for Protection of Child Rights, Children's Court Juvenile Justice Board, Child Welfare Committee, Goa State Legal Services Authority, Victim Assistance Unit of the State and all stake holders to strengthen the child protection system in Goa. As part of academic excellence, the Clinic also collaborates with leading foreign universities for sharing experiences and best practices on child protection systems.

The academic year began with a webinar hosted by IQAC of V.M. Salgaocar College of Law and

the CRC on the topic *Making Mentor Mentee Liaison Meaningful* on 11<sup>th</sup> July 2020. The idea behind the webinar was to bridge the communication gap between the Mentor and Mentee. Dr. Karl DeSouza was invited as a resource person to address the faculty of the College. Assistant Professor Ashwini Naik hosted the webinar and introduced the resource person. Dr. Kim proposed the Vote of Thanks.



Due to Pandemic and the uncertainty that was

created, the admission to the Clinic began a little later in the academic year of 2021. The entrance exam for the clinic was conducted on 5<sup>th</sup> November 2020 which was answered by 50 students. The exam was conducted in an online mode. Out of these 50 students 20 were admitted to the clinic. This year 6 students from the final year of BA LL.B and LL.B (Degree) were also admitted in the CRC Squad.

In this session, Dr. Kim Couto outlined the important provisions of the Act for the members' benefit. The second

session was on the Topic Rehabilitation of Children in conflict with Law: Challenges and opportunities which was conducted on 17th April 2021. The Resource person for this session was Advocate Rejitha Rajan who is a member of Juvenile Justice Board, South Goa. The third session was on the topic *Role of Child Welfare Committee under the JJ Act,* 2015 and the resource person was Asst. Professor Ashwini Naik. This session was conducted on 21<sup>st</sup> April 2021. The final session was conducted on 24<sup>th</sup> April 2021 on the topic *Overview of the Goa Children's Act, 2003 and the Protection of Children from Sexual Offences Act, 2012*. The

resource person for the final session was Hon'ble Ms. Vandana Tendulkar, Retired District and Sessions Judge and Former President, Children's Court.

On 6<sup>th</sup> May 2021, CRC organised a webinar for the members and for the First year and Second Year students of BALLB and LLB Degree Students on the topic *Role of Victim Assistance Unit in Supporting* 



*Victims of Child Abuse*. The Speaker was Advocate Emidio Pinho who is the coordinator of SCAN and Victim Assistance Unit at GMC, Bambolim Goa.

The Child Rights Clinic of V.M. Salgaocar College of Law, Goa participated in the GAJE/ACCLE/IJCLE Worldwide Online Conference 2021. This conference was hosted by Northumbria University from 16<sup>th</sup> to 18<sup>th</sup> June 2021. The theme for this year's conference was: "Turning Challenges into Opportunities: Justice Education in Times of Crises"

The conference, organized in partnership between the Global Alliance for Justice Education, the International Journal of Clinical Legal Education and the Association for Canadian Clinical Legal Education, brought together around 450 justice educators from across the globe. The Conference focused on the challenges brought about by the Covid 19 pandemic in imparting legal education, including the functioning of law clinics in the law universities.

The Child Right's Clinic participated in the session titled "Global Justice Education in Challenging Times". This interactive session presented the perspectives of faculty members and students of law colleges from three nations, namely, USA, India and Indonesia. The session discussed the challenges faced during the pandemic in accessing justice for the vulnerable groups. It also highlighted the role of clinical legal education and the various approaches adopted by law colleges in their clinics during these challenging times.



Ms. Anusha Almeida, a final year B.A.LLB- CRC member represented the Child Rights Clinic of V.M Salgaocar College of Law as a speaker at this conference. She highlighted the role of the Child Rights Clinic and the activities conducted by it in working towards its motto of "Building a society

where children are inspired to defend their rights". She further discussed the current challenges faced by our Clinic in our functioning due to the pandemic. ## 7. Capability Enhancement Cell

## 'Speak Easy', the Two-day Communication Skills Workshop

The Economics and Innovations Forum of V.M. Salgaocar College of Law took an initiative to organize an online Certificate course in 'Entrepreneurship Development,' during the academic year 2020-21. The course is of 30 hours duration which makes up for two Credits. The certificate course was open to all students from V.M.Salgaocar College of Law and others. As the number of students registered were 70 they were divided into two separate batches with different dates. Hence, the one month certificate course was set for the duration of 18/05/2021 to 19/06/2021 for batch one of students and 22/05/2021 to 26/06/2021 for batch two of students.

The objective of floating this certificate course for the students of law in particular is to help them get an understanding of entrepreneurial skills and the process of start ups which is now going to be the probable future of students. The certificate course targets the basic topics of entrepreneurship development and also aims at giving students practical understanding of how a business idea can be put into practice. The Students also got an opportunity to interact with Entrepreneurs who have established themselves in business. Students are made aware of the practical difficulties that arise during the process of setting up the business and how one should deal with these difficulties. The Certificate Course concluded with a Course End Examination in which students had to present their Business Plan, projecting their business ideas. Session Conducted in Academic Year 2020-21

Topic: Constitutional Morality Versus Public Morality: Understanding the Conundrum.

Speaker. (Prof) M.R.K Prasad, Professor, VM Salgaocar College of Law.

The Contemporary Legal Development Forum had organized an online lecture on the topic of "Constitutional Morality Versus Public Morality: Understanding the Conundrum" by Dr. (Prof) M.R.K Prasad, Professor, VM Salgaocar College of Law. The talk was held on 9<sup>th</sup> December, 2020 in the internet-based video-communication service platform, Google Meet. Participants from all over India attended this lecture.

The lecture delved into pertinent questions at the intersection of Constitutional Morality and Public Morality namely, contradictions between judicial law-making and contemporary public morality; evolving nature of public morality and the role of judicial precedents, conflict between constitutional morality and ideas of public morality; constitutional morality and the attendant obligation of constitutional functionaries and others' towards upholding it. The lecture while dealing with the above issues, addressed and engaged the audience with the following question and elicited their response – whether upholding constitutional morality over public morality is an immanent requirement for a progressive society?

Throughout the talk, several landmark cases among judicial precedents in constitutional law that dealt with questions of constitutional and public morality were referred to and discussed with the audience. Some of the cases that were discussed were, Justice K. S. Puttaswamy (Retd.) and Anr. Vs Union of India And Ors. (Aadhar card and public distribution system), Joseph Shine versus Union of India (Adultery), Navtej Singh Johar Versus Union of India (section 377, IPC), Indian Young Lawyers' Association vs. State of Kerala(Sabrimala) State of Maharashtra and Another vs. Indian Hotel And Restaurants Association and Others( Dance Bars). The lecture was followed by a lively interactive session, where the speaker enlightened audience by responding to their queries.

## **Objectives of the Debate Society**


- 1. To generate effective critical and philosophical thinking on the primary issues in an assigned topic.

The Orientation concluded with the announcement of the first debate.


## **First Debate**


The faculty coordinators encouraged the members to participate in the Competition. From a group of eight students who showed interest, a selection round was held to select the members for the said competition.

Salgaocar College of Law (VMSCL) in association with Stop Child Abuse Now (SCAN – GOA) organised a state level webinar titled 'Emerging issues concerning women and children's challenges, developments and a way forward'. The webinar constituted paper presentations followed by a panel discussion.

District and Assistant Sessions Judge, North Goa, Miss. Pooja C Kavlekar presented a paper on 'Admissibility of electronic evidence in cyber-crimes against women and children' wherein she discussed the issue of admissibility of electronic evidence in crimes such as child pornography, online child abuse, online stalking, cyber stalking, etc. During the course of presentation, she also made a mention of cyber defamation and morphing as emerging issues that are of increasing concern and require immediate redressal.

Assistant Professor (Law) at VMSCL, Ms. Shruti Kamat Dalal also presented a paper titled 'Roadmap of elementary education for HIV/AIDS children in India'. She expressed concern on the plight of this neglected section of society in availing of the benefit of reservation in private schools and central government schools under RTE legislation. She also suggested urgent attention of government and monitoring bodies for immediate action.

The panellists for the panel discussion constituted the following esteemed dignitaries:

Member Secretary of Goa State Legal Services Authority, Mrs. Sayonara Telles Laad,

Psychologist and Project Lead, Sangath (Goa and Pune), Ms. Prachi Khandeparkar and;

Co-founder of SCAN-Goa, Adv. Emidio Pinho.

At this webinar, Mrs. Laad mentioned that legal services institutions have created awareness even during pandemic times by reaching out to the victims in need of help. Added to this, even paralegal volunteers counsel the victims, assist victims by drafting their applications and sort out their issues.

Various insightful suggestions were given by Adv. Emidio such as ensuring safety of women and children including sex education to be imparted to children from class five; convergence between law enforcement agencies; implementation of ICPS scheme and compensation by government and functioning of DCUPs under the Juvenile Justice Act; protection policy for all institutions catering to children and women; regular burnout session cum awareness session for police,

public prosecutors, doctors and other stake holders; mandatory reporting for all stakeholders and accountability of all working for this vulnerable group and so on.

Ms. Prachi Khandeparkar gave tips to handle young children and also school-going children and adolescents. From the parents' point of view, she mentioned that healthy parenting and communication, engaging in interactive play activities, practicing mental health hygiene, maintains consistent routine, promoting health behaviour, praise good behaviours, being positive role models and practising adaptive coping is a must.

The discussion was moderated by Assistant Professor (Law), VMSCL, Miss. Ameya Nayak. The webinar was conducted online via Google Meet and provided an interactive interface for the participants to raise their questions.

II) State level Webinar on Gender Sensitisation.

On 23<sup>rd</sup> November 2020, the Human Rights Club of VMSCL, Miramar in collaboration with Stop Child Abuse Now (SCAN – Goa) and in association with Goa Rainbow Trust, a non-profit organisation working for the LGBTQIA+ community, organised a webinar on 'Contemporary Issues concerning Transgenders: Challenges, Evolution and the Path Ahead'.

Since The National Education Policy 2020 lays emphasis on inclusive education with the sole objective to provide equitable quality education to marginalised, disadvantaged and underrepresented groups, this webinar was conducted with the vision of creating gender sensitization and to count the third gender that lags behind on the human development indices of education.

Associate Professor at the Goa Institute of Management, Miss. Anamika Sinha delivered the keynote address at the said webinar wherein she stated that despite the Transgender Persons Protection of rights Act (TPA), due to bureaucratic gray zones, the community has struggled for continued income, mental and physical health, and privacy during care and has been socially ostracised.

She concluded by saying, "For a true social change, law and society members in power must liaise and create a voice."

The said webinar also consisted of a paper presentation wherein Assistant Professor (Law) at VMSCL, Miss. Shruti Kamat Dalal in her paper titled 'Transgender Children's Right to Elementary Education: Resistance and Change' stated that the country eagerly awaits the Supreme Court's implementation of the directives given in NALSA judgment of 2014 where the

government would take steps to categorise transgender children as socially and educationally backward classes of citizens and extend all kinds of reservation in cases of admission in educational institutions.

A Panellist at the panel discussion, Adv. Emidio Pinho added that their organisation SCAN is working to create an inclusive environment but lacks support from the community, and the mindset of society has to change.

Co-founder and Chairman of Goa Rainbow Trust, Francis Fernandes mentioned misconceptions that cross the minds of transgenders, especially in case of children when they are unable to identify their gender and this is the time they may experience gender dysphoria.

CEO and Founder of Goa Rainbow Trust, Chris Fernandes who is a trans person expressed discontent over the misuse of pronoun. He added that it takes a lot to undergo the medical process of transition and in this process of the journey they face gender incongruence, battling between gender assigned and gender identified.

Trustee of Goa Rainbow Trust, Nishica Gomes shared her experience of working in the past and present in the state of Tamil Nadu. She stated that there is lot of awareness as to inclusion and acceptance of transgender community in Tamil Nadu as compared to Goa. Citing the example of Kerala, she stated that other states in India have to adopt the monitoring mechanism for execution of their policy framework structured, designed and implemented by Kerala in order to uplift the community.

The panel discussion at the webinar that was conducted online via Google Meet was moderated by Assistant Professor (Law) at VMSCL, Miss. Ameya Nayak and was attended by more than 90 individuals.

The world is facing environmental problems some of which have escalated to a point of no return. Going green is the need of the hour. Human beings have to adopt practices which are environment friendly. The same applies to educational institutions too. In this regard, V. M.

Salgaocar College of Law began the green initiative. Under this initiative, teachers and students were encouraged to go green and adopt environment friendly practices.

## (a) Awareness Program on Managing E-Waste



On 8<sup>th</sup> January 2021, the green initiative committee hosted a bulk consumer awareness programme for the teaching and non-teaching staff of V. M. Salgaocar College of Law. The programme was titled as "*Managing E Waste, On and Off Campus- A guiding Session*." The resource person for the programme was Assistant Professor Sushant Figueiredo. The session concluded on a positive note with a concrete affirmation from each and every one present that they would segregate e waste and dispose of it as directed.





## (b) Grow our vegetables - Horticulture in the campus

V. M. Salgaocar College of Law decided to initiate horticulture in college after a lot of deliberations and meticulous planning. Mr. Lavu Govekar handled the initiative with gusto and enthusiasm. The plan was executed on 4<sup>th</sup> January 2021 after the College reopened. The land behind the college was leveled out. Stones, tile pieces and glass were cleared. Weeds and shrubs were cut and removed. The land was divided into plots and various seeds and shrubs were planted.



The very first tree plantation programme was conducted soon after the Republic Day celebrations on 26<sup>th</sup> January 2021. The Principal Dr. Shaber Ali and Shri D. P. Pednekar along with other teaching and Non-teaching staff planted different varieties of trees around the campus which included Banana, Coconut, Sugarcane, Mango and Soursop tree. In the forthcoming week different types of fruit bearing trees, vegetables and medicinal plants like Lady Fingers, Brinjal, chilies, cucumber, ghosali, ghungara, kidney beans, kokan dudhi, naab, Palak, pumkin, radish, sarso bhaji, tamdi bhaji, Aloe Vera, Insulin, Ashwagandha, tulsi, turmeric, shatavari, lime, guava, custard apple etc. were planted. After a lot of care and nurturing them, the vegetables grew as planned. The first harvesting took place on 4<sup>th</sup> March 2021 wherein the vegetables were garnered and sold to the teaching and non-teaching staff at a nominal price. The faculty and non-teaching staff then regularly purchased vegetables.

On 5<sup>th</sup> June 2021 the World Environment Day was celebrated at V. M. Salgaocar College of Law. On the occasion, 5 fruit bearing plants including Sitaphal, Mango, Chikoo and Lime were planted around the campus.

The World Yoga Day on 21<sup>st</sup> June 2021 was celebrated in the College with fervor. Teaching and non-teaching staff performed yogasana to mark the celebration. This day was also commemorated by planting different trees around the campus.

Vanamahotsava is a tree planting festival which is celebrated throughout India in order to create awareness about forest conservation and significance of tree plantation. V. M. Salgaocar College of Law also celebrated the event on 7<sup>th</sup> July 2021 by planting trees around the campus which included Mango, Lime and Chikoo. Apart from these fruit bearing trees, many medicinal plants were also sowed which included Manpatri, panfuti, tulsi, turmeric, aloe vera etc.

The second phase of Horticulture has been initiated in the college. Vegetables like lady fingers, pumpkin, cucumber, kokan dudhi, ghosali etc have been planted.

## 16. Annual Merit Scholarship

## (a) About the Scholarship

The Scholarships which are sponsored by the Management of the College were awarded to a total of 33 students from B.A L.L. B, L.L.B Degree and L.L.M. ## (iii) Independence Day Celebration - 15th August 2020




