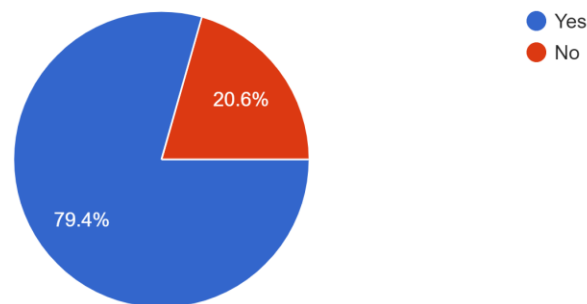
#### Suggestions for future improvisation
