

## STUDENT FEEDBACK ON CURRICULUM AND INFRASTRUCTURE

## 2020 - 2021




For the Depth of Course Syllabus, 29.2% say that it is excellent, 33.5% say that it is very good and 33.2% say that it is good.




For the Relevance of Course Syllabus in present times, 28.2% say that it is excellent, 32.6% say that it is very good and 33.2% say that it is good.








For the Learning flexibility in Courses offered, 25.7% say that it is excellent, 32% say that it is very good, and 35.7% say that it is good.




For the Optional Courses offered, 17.9% say that it is excellent, 30.4% say that it is very good, 37% say that it is good but 9.4% say that it is poor.




For the Seminar/Workshop/Guest Lectures conducted, 31.7% say that it is excellent, 30.1% say that it is very good and 29.8% say that it is good.



For the Internal Semester Assessment for Courses, 34.2% say that it is excellent, 27% say that it is very good and 28.5% say that it is good.




For the Semester End Examination for Courses, 34.2% say that is excellent, 32.3% say that it is very good, 27% say that it is good.







For Encouragement for Curricular Activities (online mode) (ADR), 24.1% say that it is excellent, 23.2% say that it is very good and 44.2% say that is good.





Suggestions on Curriculum Improvement includes, updating of book bank books; Space Law and National Security Law should be included in the courses; research paper submission should be introduced; practical mock court sessions and seminars should be conducted; considering the health of the students and their fly members, number of assignments given to students during pandemic should be reduced as this affects their internals; assessment should be research based; courses offered should be practical oriented; repealed laws should be struck off from the courses; gym and library fee was collected, but students were not allowed to access it; every student should get equal chance to participate in legal aid; power point slides must be creative and references should be used in the slides; inter college activities, weekly debates that would connect to the modern times legal issues should be encouraged, and online courses on subjects such as competition law, maritime law should be offered, workshops should be conducted on registration of patents, aviation law or cyber law and case analysis should be part of practical paper than case followings.




With regard to Infrastructural facilities that includes e-classrooms, 33.9% say that is excellent, 28.2% say that it is very good, 33.9% say that it is good.






With regard to e-Library Remote Access, 21.9% say that it is excellent, 23.2% say that it is very good, 36.4% say that it is good but, 9.1% say that it is poor and 9.4% say that it needs improvement.





As far as ICT is concerned, 23.5% say that it is excellent, 27.6% say that it is very good, 37% say that it is good, 6.6% say that it is poor and 5.3% say that it needs improvement.



For Book Bank facility provided, 32.9% say that it is excellent, 24.1% say that it is very good, 30.4% say that it is good, 7.2% say that it needs improvement and 5.3% say that it is poor.

Suggestions on Curriculum Improvement includes, improvisation of e-library facility; access to SCC Online; orientation on accessing the college library; provide students with study material; reduce lectures per day and give little longer breaks as continuous classes are difficult to concentrate; provide book bank books before the semester; plant more trees and set gardens around the campus; provide bare acts in book bank; building walls need to be repainted and Air conditioners should be repaired.
