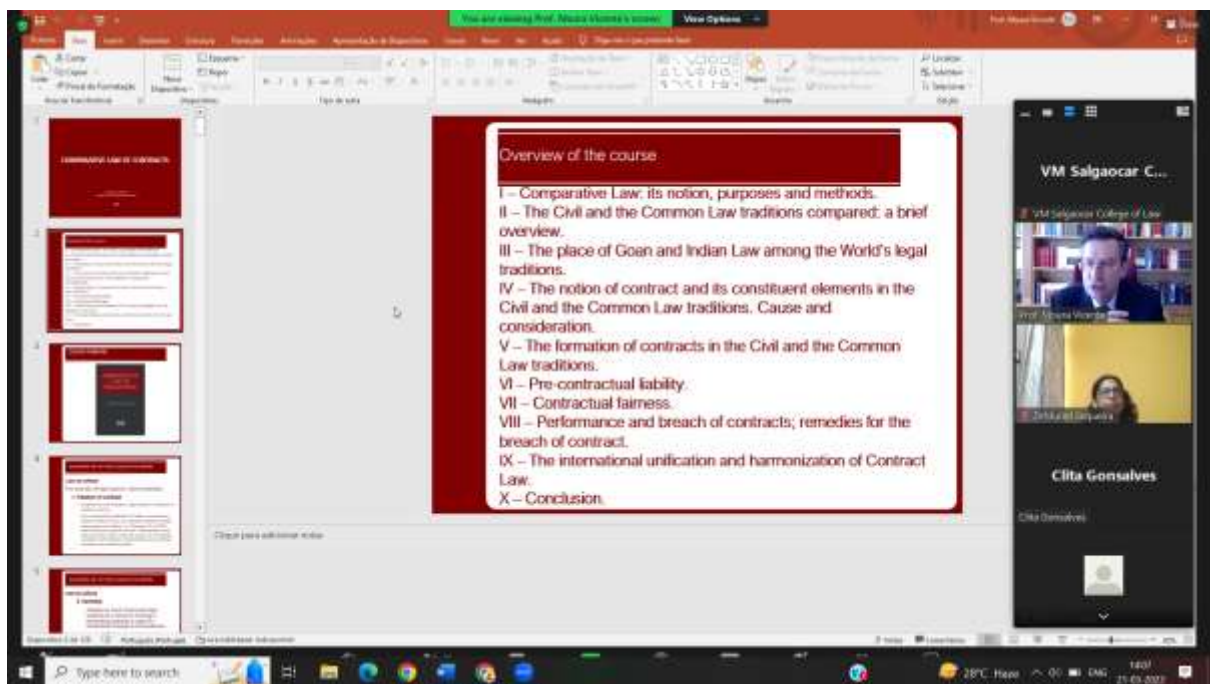
WEEK 5 - Dr.M.R.K.Prasad COMPARATIVE CONSTITUTIONAL LAW held on 18-19 and 29, 30 March
