#### **About ADR Board**

ADR Board of the College is involved in imparting training and exposure to students in Alternate Dispute Resolution through effective client counseling, negotiation and mediation. Two faculty members coordinate the programs in consultation with an Advisory Committee. Following the orientation sessions for all students, a selection round is held to select students to become members of ADR Board. The members are further trained and sent to represent the college at the National and International Competitions. ADR Board also conducts compulsory negotiation sessions for final year students, as part of their practical paper.

#### **Orientation Session**

Orientation sessions for the students registered for the selection rounds of the ADR Board were conducted by Dr. B. S. Patil on 29<sup>th</sup> October 2021.

#### **Selection to ADR Board**

Notice was issued for the purpose of registration for selection rounds to the ADR Board on 27<sup>th</sup> October 2021 with last date as 30<sup>th</sup> October 2021. 74 students registered for the selection rounds. The Selection Rounds were held on 29<sup>th</sup> October 2021 in chambers, involving faculty members as assessors namely Dr. MRK Prasad, Dr. Sandhya Ram S.A, Dr. B.S. Patil, Dr. Mrunmayi

Vaidya and Asst. Prof. Pearl Monteiro. A total of 37 students were selected and another 06 were selected as Honorary Members. Exemption from selection process was given to 10 former members who had achievements to their credit from previous years' National/International Competitions.

### **First Meeting of the ADR Board (29<sup>th</sup> October 2021)**

Faculty coordinators presided the meeting. The new members were welcomed to the ADR Board and the work culture and duties of members were discussed and assigned. Students were encouraged to conduct session for the members. Students were also encouraged to write articles in research journals. A list of competitions was chalked out and students interested in participating, registered for the events.

### **Generation of Negotiation Fact Sheets**

A total of 04 negotiation fact sheets were generated during the year framed by Dr. Sandhya Ram. Confidential Information was prepared by Dr. B.S.Patil. The fact sheets were used for ADR Board selection round and compulsory negotiations.

### **Compulsory Sessions for final year students**

Compulsory negotiation was held on 19<sup>th</sup> and 20<sup>th</sup> of May 2022 for the Final year of the Five years as well as the Three years course. Factsheet was uploaded on the website a week before the dates of the sessions. Total of 180 students participated in the rounds over two compulsory sessions to be undertaken by each student. They were assessed by 21 faculty members. The sessions were carried out in 16 classrooms.
