BUDGET AND PARAMETERS FOR ENHANCEMENT OF MOOT COURT SOCIETY

The academic activities of the Moot Court Society 2021-22, commenced with the preparation of an annual budget for the successful functioning of the society that was submitted to the College Principal and Administrator.

The following parameters were enlisted for enhancement of the society:

The Competition

Quarter finals were conducted in the afternoon which were judged by 8 judges. 4 teams which qualified on basis of knock out in the quarter final rounds, proceeded to semi-finals.





24th April 2022 – Semi final, Finals

The 4 teams selected from quarter finals, proceeded to compete in semi-finals. Semi finals were judged by 4 judges. 2 teams were selected by knock out from semi-finals to compete in finals.



Final round immediately followed the semi final round. Sr.Advocate Shri Saresh Lotlikar, Sr.Advocate Shri Ramchandra Ramani and Sr.Advocate Shri. Cleofato Coutinho judged the final rounds.
