- 4. The scheme and solution for the question paper are to be prepared as per the instructions and to be inserted in the cover labelled "Answer Key" and to be sealed.

INSTRUCTION TO QUESTION PAPER SETTER FOR THE PREPARATION OF SCHEME AND SOLUTIONS

- a. The paper setters shall write the questions in <u>legible handwriting or print them</u>.
- b. The Paper Setters shall identify Bloom's Level (BL) and Course Outcomes (CO) for each question.
- c. The Paper Setters shall set two questions from each module, of which the student is expected to answer one.
- d. All questions will have an internal choice and carry the same weightage of 10 Marks.
- e. Paper setters can also give problem-based questions; however, the problem shall be within the module.
- f. The solution to the problem-based questions should indicate the expected important points like right advice/logical and legal reasoning/legal principles/ decided cases/application along with the marks allocation for each of these.
- g. The solution shall not be in the form of references/citations where authors' names/titles of the book/chapter numbers/page numbers/paragraphs etc are indicated as

- i. If the solution for a question has components, marks are to be allocated for each component explicitly. (example 5+3+2=10).
