

The Legal Education Committee of the Bar Council of India at its meeting held on 27th April, 2019 considered the letter No. VMSCL/PERS/2018-19/32 dated 4th June, 2018 received from Dr. M.R.K. Prasad, Principal, V.M. Salgaocar College of Law, Goa. After consideration, the Committee is of the view that since the default of not applying for extension of both three year LL.B and five year BA LL.B courses was admitted by the college and they have deposited the default amount based on principle of the then Justice Kurain Joseph. Hence, the students admitted stands regularised till the academic year 2017-2018.

In view of the above, the admissions made by the V.M. Salgaocar College of Law, Panaji, Goa in respect of three year LLB course from 2011-12 to 2017-18 with intake of two sections of 60 students in each section and five year BA LL.B course with intake of two sections of 60 students in each section from the year 2008-09 to 2017-18 are regularised. The application made from the year 2018-19 for extension of approval of affiliation for both the courses will be considered after the inspection of the college.

The above recommendations have been confirmed by the General Council of the Bar Council of India on 19th May, 2019.


