V M Salgaocar College of Law (VMSCL), in partnership with the environmental NGO Dhavrukh, successfully completed a groundwater conservation project on its campus. This effort is part of the Bhujal Sanvardhan initiative, which focuses on tackling the issue of groundwater depletion through sustainable water management practices. The project was carried out under the direction of Rudresh Mhamal.


The project includes the installation of a rainwater harvesting and groundwater recharge system designed to capture and store rainwater, channelling it into the soil to replenish shallow aquifers. With the capacity to recharge up to 20 lakh litres of groundwa-

ter annually, this system is crucial for conserving the vital natural resource. Additionally, it serves as an educational model, promoting water conservation awareness among students, staff, and the local community.

The project was carried out under the leadership of Principal Dr G Shaber Ali and Administrator D P Pednekar, with coordination provided by Assistant Professor Ramrai Naik and Audumber Uskaikar.

VMSCL has encouraged individuals and institutions to undertake similar initiatives, which can collectively lead to significant and environmental benefits. The college's green campus efforts have earned numerous accolades, including the District Championship Award from Edu Trust India.
