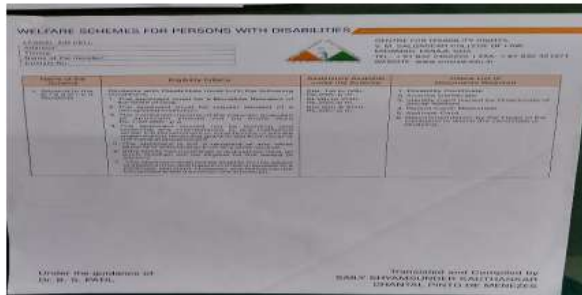

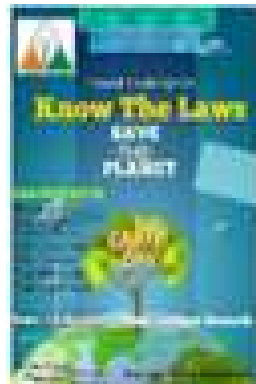

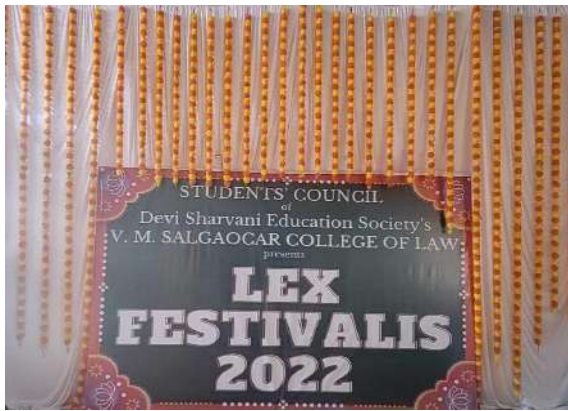


Figure 5 Lex Festivalis

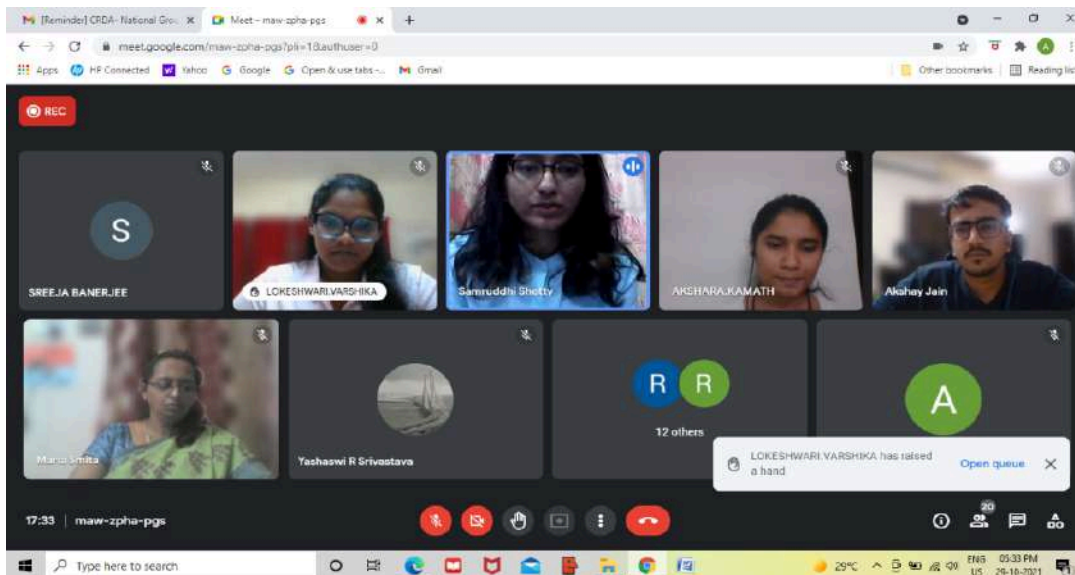


Figure 8 ACCESS TO PEOPLE WITH DISABILITIES TO CULTURE, TOURISM, SPORTS AND LEISURE
