Copy of the consolidated feedback/ suggestions from all stakeholders is annexed to this letter for your consideration and necessary action.

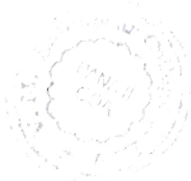


