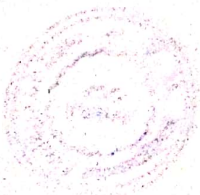

3.	Students	Guest lectures should be focused on student's interest, to identify the	A survey will be conducted to identify student interest. Based on that, the IQAC has decided to make videos

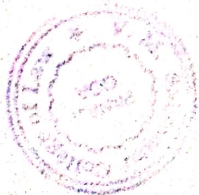
