Salgaocar College of Law to act as a suitable platform to serve the society by understanding, addressing the needs of the disabled and by providing with an opportunity to come up with innovative solutions to protect and uphold their rights. It provides practical knowledge through first-hand experience byworking with various government departments and lawyers. It helps in developing the skills of research and drafting which is of utmost importance in legal profession.

The participation is itself of immense value. It would serve as platform for interaction with diverse sets of people and be part of seminars which can be extremely informative and knowledgeable. Learning and exploring something new can make the mind more creative and serves as a door way to world of micro-minority community which might not have earlier thought of and understanding their difficulties would help the students to be a better human being.

The members of CRPD are selected through group discussion activity which tests the Student's knowledge and also their ability to inculcate empathy and address the issues of the specially abled persons.

#### 1. World Autism Day

The Office of State Commission for Persons with Disabilities and Directorate of Social Welfare, Government of Goa, conducted an awareness on Autism as April is National Autismawareness month. The program began with a skit performed by the students creating awareness on how to observe signs of autism in children which appear in age between 2-3 years old and showed how one must accept people with autism as a normal human being. The Volunteers were given pamphlets to do distribute to the public present there to further create awareness among each and every one present there. The program then came to an end with the talk given by the guest speakers present there.

#### 2. Parasports for person with disabilities

CRPD Members were part of the organizing committee of the Para sports event conducted by Sports Authority of Goa at Campal on 2<sup>nd</sup> February 2022 and ensured smooth functioning of the function. #### 3. Action planon spreading awareness unique disability Id

The discussion was hosted by Vaishnavi S and Zoya on February 22<sup>nd</sup> 2022 which aimed at spreading awareness regarding the advantages of UDID registration, its procedure for the specially abled persons. Various members including AshwinNaik, Adityarana, Sakshi, Shikha Joshi and Cassia had provided productive inputs for the program.

# 4. Access to people with disabilities to culture, tourism, sports and leisure

#### 5. Faulty disability certificate case

Persons with Disability are issued faulty disability certificates by the issuing authorities. The Complainant has made various requests to rectify the same. Currently Ashwin Naik and Shikha Joshi are pursuing the case of the complainant at the Goa Human Rights Commission. The hearing for the same was last conducted on 27.06.2022 and we are awaiting the final Judgement.

## 6. Grant of lmv (automatic)/adapted vehicle licence for the persons with disability.

The applicant has made a prayer to the Directorate of Transport to issue to him licence for MCWOG and Adapted vehicle both on a single document; secondly to grant him a LMV (Automatic/AMT) licence. Presently the appeal is made before the Director of Transport and their orders are awaited. Ashwin Naik is following up on the case along with the applicant.

# 7. "An introduction to disability research-a legal and social studies perspective".

Centre for Disability Research & Training, Kirori Mai College, University of Delhi in collaboration with National Centre for Promotion of Employment for Disabled People (NCPEDP) conducted a two credit online certificate course. Ashwin Naik completed the Certificate Course with a grade of B+ which ran over a period of 9 weeks, starting from 16th February, 2022. The course comprised of-

- We need to prepare a formal communication letter addressed to the Department.
- Briefed them that we have an active legal aid cell having good reach to help in promotion
