6) Diploma in Civil Law and Practice Summary Report (2021-2022)

Introduction:

The *Diploma in Civil Law and Practice* was conducted by V.M. Salgaocar College of Law, Miramar, in collaboration with the Faculty of Law, University of Lisboa from October to November 2021.
