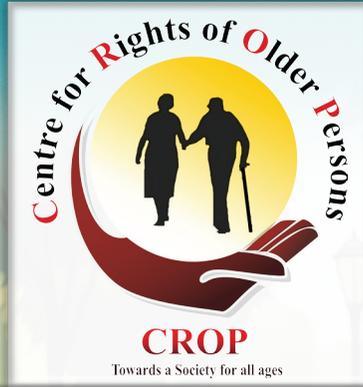




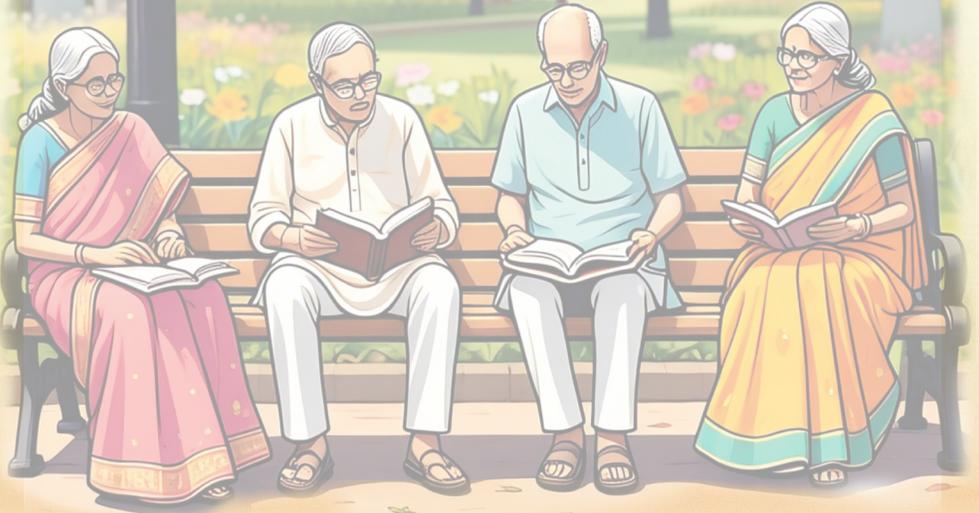

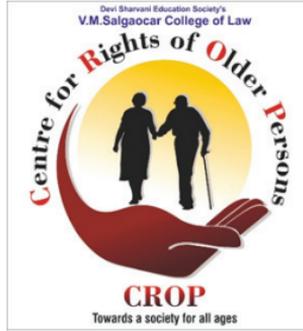

PREFACE

Rare is the poet who lives to old age but does not write about it. William James Collins is an American poet who wrote about old age as thus:

*“As if, one by one, the memories you used to harbor
decided to retire to the southern hemisphere of the brain...
No wonder you rise in the middle of the night
to look up the date of a famous battle in a book on war.
No wonder the moon in the window seems to have drifted
out of a love poem that you used to know by heart.”*

Human rights are the rights inherent in every human being. All persons are equally entitled to live with human dignity. Ageing does not result in a loss of human rights. The Human rights do not wither away as a person grows in age, though the bodily faculties may wither in what the great poet John Keats writes as the “Winter ... of pale misfeature”. It is a fact of life that as a person advance in age, she may require support and assistance in terms of physical, emotional, and financial aspects. As a result, they need special care and support to insure that their rights are not violated.

Keeping that in mind, the Parliament of India has enacted The Maintenance and Welfare of Parents and Senior Citizens Act, 2007 to ensure that the parents and senior citizens are looked after and cared for in their advancing years. Subsequently, in 2009, the Government of Goa made Rules to implement the law in Goa. In addition to the Act and Rules, the Social Welfare Directorate has announced a number of welfare schemes for senior citizens.

The student members of the Center for Rights of Older Persons (CROP)

of V.M. Salgaocar College of Law have prepared this booklet to aid the senior citizens to know their rights and entitlements under the law. This booklet contains information on the Act, Rules and Schemes that a senior citizen in Goa can avail and should know about. This Booklet will be useful for anyone who wishes to know about the law and the welfare schemes of the Government of Goa relating to senior citizens. The information is put in a simple format that can easily be understood by anyone.

RIGHTS OF PARENTS/ SENIOR CITIZEN UNDER THE MAINTENANCE & WELFARE OF PARENTS AND SENIOR CITIZENS ACT, 2007

A. RIGHT TO CLAIM MAINTENANCE

“Maintenance” means having sufficient food, clothing, residence, medical care and treatment that is necessary for a person to have a normal life.

Senior Citizens and Parents have the right to apply for maintenance from their children. In case of a childless senior citizen, the maintenance can be claimed from relatives. The details are given in the table below.

WHO CAN APPLY FOR MAINTENANCE?		FROM WHOM?
1	Parents of any age who are unable to maintain themselves out of their own earning or out of property owned by them	From their children who are not below 18 years of age Children may be biological, adopted or step-children.
2	Grandparents who are unable to maintain themselves out of their own earning or out of property owned by them	From their grandchildren who are not below 18 years of age

3	Childless senior citizens	From any relative (legal heir) who is 18 years old and above, who has sufficient income
		NOTE: This relative must be having the property of the childless Senior Citizen or would be getting such property after the death of the Childless senior citizen.

HOW AND WHERE TO APPLY FOR MAINTENANCE

- 1) The application is to be submitted to the Maintenance Tribunal in the District where the parent/senior citizen resides or where the children/relative resides.
- 2) Application to be made on any ordinary paper as per the format of 'FORM A'(Sample of FORM A on **page 14**)

NOTE 1 : For list of Maintenance Tribunals, kindly refer to **page 12** of this booklet.

NOTE 2 : If any person is not able to fill the FORM A on their own, then any other person, Or NGO can fill and submit the form A on behalf of the person.

- 3) The Tribunal can also take also take up a case of its own without any application made by the senior citizen/parent

AMOUNT OF MAINTAINENCE:

The Tribunal may order monthly allowance to be paid. The amount shall not be more than the total income of the opposite party divided by the total number of persons who depend on such income. However, the maximum amount of maintenance shall not be more than Rs. 10,000/- per month.

B. RIGHTS OF SENIOR CITIZENS WITH RESPECT TO MEDICAL CARE

THE STATE GOVERNMENT MUST ENSURE THE FOLLOWING PROVISIONS FOR MEDICAL CARE OF SENIOR CITIZENS	
1	Dedicated Beds in fully or partially government-funded hospitals, as far as possible.
2	Separate queues for Senior Citizens.
3	Expanded facilities for treatment of chronic, terminal, and degenerative diseases.
4	Expanded research for chronic elderly diseases and aging.
5	Earmarked facilities for aged patients in every district hospital.

C. RIGHT TO ADMISSION IN OLD AGE HOME

Poor and needy senior citizens can avail the facilities of an Old-age Home managed by the Government of Goa through the Institute of Public Assistance Provedoria.

WHAT FACILITIES ARE PROVIDED IN OLD AGE HOMES?

- a. Separate living spaces for men and women.
- b. Safe water for drinking and other uses.
- c. Good electricity connection, fans and heating arrangements.
- d. Sufficient number of toilets and bathrooms, including those specially designed for disabled persons.
- e. Entertainment options such as television, newspapers, books, and other fun activities.
- f. Health care facilities, including first aid, special resting rooms for those who are unwell and medical staff.
- g. The home is designed with features to support physically challenged senior citizens, including slopes and support bars for walking.

ADMISSION PROCESS:

1. The application will be made available at least once a year for poor and needy senior citizens.
2. If the number of eligible applicants is more than the number available places, then selection will be as follows:

- a. Importance will be given to senior citizens who are more in need over those who are less needy.
 - b. Older senior citizens will be selected over younger ones.
 - c. Female applicants will be given importance over male applicants.
3. If a senior citizen is uneducated, physically weak and in urgent need of shelter, no formal application is needed if the District Magistrate is satisfied.

**D. PROTECTION WITH RESPECT TO TRANSFER OF PROPERTY
BY SENIOR CITIZEN**

The senior citizens can approach the Maintenance Tribunal and apply for cancellation of the transfer of any property made to any person, if some conditions are satisfied.

Conditions:

1. A senior citizen has transferred his or her property after July 22, 2008
2. In the transfer deed a condition is made that the person who receives the property would take care of the basic physical needs of the senior citizen

3. The person who receives the property does not take such care of the senior citizens.
4. If the children or relatives do not provide maintenance to the Senior Citizen.

NOTE 1:

If any Senior citizen is not able to approach the Tribunal on their own, then any legally registered voluntary association (NGO) can file on their behalf.

NOTE 2:

For List of Maintenance Tribunals, kindly refer to page 14 of this booklet.

5. The Tribunal after hearing the opposite parties can cancel the transfer of the property as if the transfer was done through fraud, force, or undue influence.

E. RIGHT TO PROTECTION OF LIFE AND PROPERTY

Every Senior citizen has the right to a peaceful and protected life. The Maintenance and Welfare of Parents and Senior Citizens Act, 2007 provides for protection of life and property for the Senior citizens. The rights have been listed below.

1. **Right to be registered:** Each Police station will keep an updated list of senior citizens in their area, especially those living alone.
2. **Right to Regular visits:** A Police representative, social worker, or volunteer will at least visit once a month any senior citizen who lives alone.
3. **Right to Quick Response:** If a senior citizen requests any help from the Police, the police will respond quickly and offer help.
4. **Volunteer Committee:** Each police station will form a Volunteer Committee to make sure that there is regular

contact between the senior citizens (especially those living alone) and the Police.

5. **Speedy Verification of domestic servants and workers:** If a senior citizen makes a request for verification of their domestic servants or other workers, the Police will quickly verify the same.
6. **Right to Security:** Senior citizens will be provided with additional security through community policing efforts involving local senior citizens, Resident Welfare associations, Youth volunteers, and NGOs etc.

DETAILS OF MAINTENANCE TRIBUNAL

The Government of Goa, vide Notification No. 83-09-2006-07-SDB/Part/2008/3846, dated 24th September 2009, has constituted a maintenance Tribunal for each Sub-Division of the State of Goa which is presided over by the respective sub-divisional Officer for the purpose of adjudicating and deciding upon the order for maintenance under Section 5 of the said Act.

SCHEMES AVAILABLE FOR SENIOR CITIZENS IN GOA

NOTE :Application forms for all schemes mentioned below are available with the Officer of the Social Welfare Department who is available at every Village panchayat and Municipality.

I. ISSUE OF IDENTITY CARDS TO SENIOR CITIZENS.

To be eligible for a Senior Citizen Card in Goa, you must meet the following criteria:

1. Must be an Indian citizen.
2. Should Have valid proof of age, such as a birth certificate, passport, or other government-issued document, to show he/she is over 60.

While Applying for the Senior Citizen Card, one must provide the following documents:

1. **Proof of Age:** such as Birth certificate, Passport, or any other government-issued age proof document.
2. **Address Proof:** Documents: like Aadhaar cards, voter IDs, or utility bills can serve as address proof.
3. **Passport-sized Photographs:** Recent passport-sized photographs of the applicant.
4. **Identity Proof:** Any government-issued identity card such as an Aadhaar card, PAN card, or voter ID.
5. **Complete Application Form:** You can obtain this form from your local government office or download it online.

THE PROCESS

Applying for a Senior Citizenship Card is a straightforward process:

1. Obtain the application form from your local government office or download it online.
2. Fill out the form accurately and attach the required documents.
3. Submit the completed application form and the documents to the designated government office.
4. After verification, you will receive your Senior Citizenship Card by mail or in person.

BENEFIT: 50% concession is given in KTCL Buses within the state of Goa.

II. DAYANAND SOCIAL SECURITY SCHEME (FREEDOM FROM HUNGER)

The Dayanand Social Security Scheme is a state-level initiative by

the Government of Goa aimed at providing social security benefits to economically disadvantaged residents of the state. The scheme was launched in the year 2001.

Objective: The primary goal of the scheme is to provide financial assistance and support to individuals and families belonging to economically weaker sections of society. It aims to improve their quality of life by offering assistance in various areas such as healthcare, education, and livelihood support.

Eligibility Criteria: The scheme typically targets individuals or families below a certain income threshold, as determined by the state government. Eligibility criteria may also include factors such as age, disability status, and social category (if applicable).

Benefits Offered: The scheme provides a range of benefits to eligible beneficiaries, which may include:

1. Financial assistance for healthcare expenses, including medical treatment and hospitalization.
2. Educational support, such as scholarships or subsidies for school fees, books, and uniforms.
3. Livelihood support through skill development training, job placement assistance, or financial aid for income-generating activities.
4. Pension or financial assistance for senior citizens, widows, persons with disabilities, or other vulnerable groups.
5. Housing assistance for homeless or low-income families.

The Process

Individuals who wish to avail themselves of the benefits under the Dayanand Social Security Scheme usually need to apply through a designated process. This may involve filling of an application form and submitting relevant documents to prove eligibility, such as identity proof, income certificate, residence proof, and any other required documentation.

Required Documents: Applicants are typically required to provide documents such as -

- Proof of identity (Aadhaar card, voter ID, passport, etc.).
- Proof of residence (ration card, electricity bill, etc.).
- Income certificate or proof of income status.
- Caste certificate (if applicable).
- Disability certificate (if applicable).
- Bank account details for direct benefit transfer.

III. UMMID SCHEME OF GOA

The Scheme came into force on 7th September 2006

The scheme aims at ensuring good physical and mental health and providing the senior citizens with their daily requirements like spectacles and walking aids besides providing various grants for newspapers/periodicals, telephone, sweeping and cleaning, TV/radio and light refreshment /tea to the members.

Objective:

This Scheme is for giving hope to the senior citizen by taking care of their old age requirements. The main objectives of this scheme are:

1. To provide daily required things like hearing and vision testing and supply aids, spectacles and walking aids
2. For keeping good physical and mental health in “day care centre”.

Target Beneficiaries:

1. All citizens of the state aged 60 or above who have been residents of Goa for the last 15 years.
2. Their income shall not exceed Rs. 60,000 per annum.

IV. MUKHYAMANTRI DEV DARSHAN YATRA YOJANA

Objectives of the scheme: The Government of Goa, in an initiative to help people particularly Senior Citizens to have the blessing of the almighty God, introduced this scheme. The Scheme is called “Mukhyamantri Dev Darshan Yatra Yojana”

Eligibility Criteria Pattern of Assistance

The applicant shall be not less than 50 years of age.

Assistance Available under the scheme:

The pilgrimage shall be sent under the Indian Railways Catering and Tourism Corporation Ltd. (IRCTC) package as per the MOU signed by the Government with IRCTC.

Procedure to avail of benefits

The application is to be filled out & submitted to the Directorate of Social Welfare.

Checklist of Documents required

- The applicant shall submit a copy of their Aadhar card and voting card
- Attendants shall submit a copy Aadhar card and voting card.
