## **CIRCULAR**

In view of the strict compliance of the directions of the Honourable Supreme Court w.r.t. the POSH Act – 2013, the allowing guidelines need to be followed for the effective implementation of the Act:

a. Head of the Institution, who is the PIO of the school, need to be aware of the Section 16 (Confidentiality Clause) in Section 17 (Consequences of Breach of Confidentiality) of the Posh Act.

b. Under Section 12(1) of the POSH Act, the Internal Committee may recommend to the employer to grant leave to the aggrieved women as per Rule 48 of CCS (Leave) Rules 1972.

 c. Annual Report as per POSH Act shall be sent to District Collector and to DoE every calendar year as per prescribed format.

  - POSH Compliance Clinic would be able to render assistance in the implementation of the following in schools:
  - Verify the constitution of Internal Committee.
  - Assist in the preparation of disclosure content which is required under law.
  - Support in drafting and verifying the Policy on Prevention of Sexual Harassment.
  - Conduct training to IC members on the law and procedure of inquiry into complaints of sexual harassment.
  - Advise the institutions and the IC's on the point of law and procedure.
  - Conduct awareness talks to students and staff of the schools.
